

AN ORDINANCE

ADOPTING ENVIRONMENTAL RULES AND REGULATIONS OF THE LOWNDES COUNTY BOARD OF HEALTH AS AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF LOWNDES COUNTY, AND FOR OTHER PURPOSES.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF LOWNDES COUNTY:

Section 1

The following attached rules and regulations of the Lowndes County Board of Health are hereby adopted as and made an ordinance of the Board of Commissioners of Lowndes County:

- (A) Rule II of the Board of Health regarding Rabies Control attached as Attachment A
- (B) Rule III of the Board of Health regarding On-site Sewage Management Systems (based on Georgia Department of Public Health Rule 511-3-1) attached as Attachment B
- (C) Rule IV of the Board of Health regarding On-site Water Supply attached as Attachment C
- (D) Rule V of the Board of Health regarding Food Services (based on Georgia Department of Public Health Rule 511-6-1) attached as Attachment D
- (E) Rule VI of the Board of Health regarding Swimming Pools, Spas, and Recreational Water Parks attached as Attachment E
- (F) Rule VII of the Board of Health regarding Tourism Accommodations (based on Georgia Department of Public Health Rule 511-6-2) attached as Attachment F
- (G) Rule VIII of the Board of Health regarding Body Art attached as Attachment G
- (H) Rule IX of the Board of Health regarding Portable Sanitation (based on Georgia Department of Public Health Rule 511-3-6) attached as Attachment H

Section 2

Violations of this Ordinance shall be prosecuted before the Magistrate Court of Lowndes County as provided in Article 4, Chapter 10, of Title 15 of the Official Code of Georgia Annotated. Violations of this Ordinance may be tried with or without a prosecuting attorney. Citations for violations of this Ordinance may be issued by employees of the Board of Commissioners of Lowndes County authorized to issue citations for violations of ordinances of the Board of Commissioners of Lowndes County or by employees of the Lowndes County Board of Health who are also hereby authorized to prosecute violations of this Ordinance on behalf of the Board of Commissioners of Lowndes County.

Section 3

This Ordinance shall have application in the unincorporated area of Lowndes County, Georgia.

Section 4

The maximum punishment which may be imposed for a violation of this Ordinance shall be a fine of \$1,000, or imprisonment for sixty (60) days, or both.

Section 5

This Ordinance shall be effective upon its approval by the Board of Commissioners of Lowndes County.


Section 6


All resolutions and ordinances or parts of resolutions or ordinances in conflict with this Ordinance are repealed.
